“Arago My Arago” -By *Frank Mitchell*-Byway Ambassador & Hubbard County Historian

Arago Township was organized on April 1, 1896. The two townships, now Arago and Clover, organized as one township. Hay Creek runs through Arago Township, so the area was known as Hay Creek and Hay Creek South.

Chas. Martin homesteaded the N.W. ¼ of section 8 in Twp. 141. In the local news in 1896 it was stated, “There is a move to establish a Post Office here”. On November 19, 1897 the Arago Post Office was established, with Chas. Martin as postmaster. At first the post office was in his log home. After this the area was known as Arago and South Arago. Mr. Martin later added a livery stable, a store and the “Fairview Hotel” with a dining room.

About 1906 Henry Michel took over the post office and moved it to his property about ½ mile north. He built a 12 x 20 foot building on his property. This was used as the post office until it closed about 1960. The building is still standing in the same location on the hill next to the highway.

In the local news of July 23, 1908 the headlines read, “Arago Store Sold”. Henry Michel sold ½ section of land to D.B. Short of Two Inlets. The sale included the post office, the store with stock of goods, and the residence. Mrs. Michel resigned as postmistress and Mrs. D.B. Short was appointed to take her place. Later Daisy Renhard, the Short's daughter, was postmistress until the post office closed.

June 14, 1906 “There is to be another store in Arago before many moons”. This was possibly at Bill Pritchett's mill 1 mile north of the post office.

In 1922 a club was organized in South Arago, known as the “Jack Pine Farmers Club”. In the spring of 1923 a 24x40 foot log clubhouse was built. The building was on property leased from Frank Beden on the SW ¼ of the SE ¼ section 27 in Township 141. There was a U.S. observation tower on the SE ¼ of section 21. Little is known about it except that it blew down in a windstorm in 1909. This was probably on the present Brumbaugh property.

A notice in the Hubbard County Clipper asked for sealed bids for the construction of a bridge across Hay Creek on section 9. Bids will be considered by the County commissioners on May 21, 1892 at 2 o'clock. This was for the 2nd bridge built across Hay Creek. On September 8, 1904 R. Esser was awarded the contract to build a new bridge across Hay Creek. On April 13, 1905 S.L. Massie, with a crew of men and horses are at work on the approach to the new bridge.

In 1938 state highway crews were busy surveying a new location of Highway 71 to cross Hay Creek about ¼ mile down stream, or east of the present bridge. This will eliminate the

sharp curves in the present road. On July 18, 1940 the headlines read “New Bridge Falls Down”. The new bridge or box culvert collapsed and fell into the river. The culvert 8x10 ft. inside and 126 ft. long had just been finished and was being covered with 15 ft. of dirt when a large hole opened up and caused the culvert to collapse. This blocked the flow of water and caused several months delay in opening up the new highway. Traffic was detoured by way of Two Inlets. It was expected to cost the state \$15,000.00 to replace it. The accident was blamed on the highway engineers who made the original survey.

There were 3 schools in the township. The 1st one organized was district 15, in 1895. This schoolhouse was built on the Hemmerick property in the NE ¼ of section 18. The building was later moved to the SE ¼ of section 5 and is still being used for the town hall. The 2nd school was district 21, which was granted in 1896 when Mr. Judenitch petitioned the county commissioners for a district in South Arago. The school was built on the NE ¼ of the SE ¼ section 19. This building has been moved to the Pioneer Farmers Club grounds north of Itasca State Park, where it was refurbished and is open to the public during their shows. The 3rd school was on the Beden property near the Jack Pine Farmers building.

In 1917 a cemetery was surveyed and fenced in section 5. This is the Arago/Clover Evergreen Cemetery. This cemetery has been enlarged and is being used at the present time. A new sign was put up over the gate in 2003.

In 1892 the newspaper reported “The new wagon road recently laid out to Lake Itasca via Hay Creek will shorten the distance about 5 miles”.

In the local news of June 23, 1909, “D.B. Short has his new hall nearly finished”. Later in the news “Big Dance at Arago Hall July 3rd, come one, come all and bring your best girl”.

Bill Pritchett had a sawmill on the little lake north of the post office. He had a sawmill, lath mill and a shingle all powered by separate steam engines. He also had a small store with gas pumps. I remember hearing the whistles from the steam engines at noon and at quitting time, even though we lived 3 ½ miles away. He dumped logs on the ice during the winter, and then floated them in as he sawed them.

Lake Country Scenic Byway Extends Condolences to the Family of Carolyn Tschudi

Carolyn Marie Tschudi, 72 of Bad Medicine Lake, Becker County died Tuesday, Dec. 20, 2005 at her home.

She was born May 29, 1933 to William M. and Emma H. (Heegard) Simmons in Park Rapids. She grew up in Green Valley Township and attended Dist. 110 country school. She graduated from Park Rapids High School in 1951. She attended one year of normal teachers training in Park Rapids. For two years she taught first through eighth grade at country schools near Perham and Alexandria.

She married Donald C. Tschudi July 10, 1953 at Fort Bliss, TX. They lived in Texas and she worked as a switchboard operator. They lived in Germany one year and then Wilmington, DE from 1958 to 1960. They moved to Minnesota and purchased Bad Medicine Lake Resort in 1960. They provided seasonal

Sunday church services at the resort, creating “Chapel of the Good Creation.”

She began square dancing in 1953 with the Alexandria Area Square Dancers Club. She was a member of the Osage and Park Rapids Area Friendly Squares Club. She served as regional officer and as Minnesota State Federation president and convention chairs. She served as a state fire warden for 45 years.

She was a volunteer member of several area tourism boards, including the Itasca West Recreation Area Tourism Group, the Land of Legends Tourism Group, Friends of Itasca Park Board, Lake Country Scenic By-way and the Bad Medicine Lake Area Association. She was a member of the Faith Baptist Church in Park Rapids and a former member of the Osage Baptist Church where she taught Sunday school.

She is survived by her husband; two daughters, Janet Archer of Douglas and

Cheryle “Shari” (Rusty) McFarland of Spring Valley; brother, Richard of Park Rapids; and two grandsons.

She was preceded in death by her parents. Funeral: Friday, Dec. 23 at Faith Baptist Church in Park Rapids with Pastor Marty Giese officiating.

Memorial service: 11 a.m. Sunday, May 28, 2006 at Bad Medicine Lake Resort at the Chapel of The Good Creation.
