Two County Treaurer's Zimbrick & Fox From the desk of Hubbard County Historian...Frank Mitchell

It was August 1, 1891. A big celebration was planned commemorate the arrival of the first train coming into Park Rapids on the newly laid tracks from Wadena. During the morning, a cannon was to fire 3 shots. Three inexperienced young men were allowed to fire the cannon. shots were fired but the 3rd charge ignited prematurely

injuring all Will three men: Zimbrick, Willie Fox and John Grandy. Will Zimbrick and Willie Fox each suffered the loss of both Both men recovered and did their best to make a living and they each led a normal life.

Willie Fox was Born July 21, 1872, and came to Hubbard County with his parents in 1879. He married Emma Chandler and lived on a farm later known as the Becker He was engaged in Farm. farming, logging and hired out as a teamster. He drove a four horse team and even went to the Dakotas and pitched bundles during harvest season. He had his stub arm equipped so he could use a pitchfork, saw fire wood with a sweedsaw, shoot his rifle and do many everyday chores. He was the great uncle of Margaret (Bauman) Edelman who lives in Lake Alice Township where he lived until a few years before his death. After being in ill health for several years at which time he lived with his niece, Mrs. Frank Bauman in Lake George. He died of a heart attack on November 11, 1954. His wife had died in 1943 and no children were born to this couple.

Will Zimbrick was elected Treasurer of Hubbard County in 1896. In his first campaign he ran against J. W. Smith and A. E. Dickenson. The final vote for Smith 213, Dickenson 231 and Zimbrick 299. He was re-elected twice until beat by Willie Fox in 1902. The tally was Zimbrick 727 and Fox 738. Fox lost the next election to Mr. Wilsie in 1904.

This is certainly an account of will power for both men. Even with the loss of their arms they didn't burden the taxpayers but went

ahead and did the best they could to make a living and support their wives.

The obituary for Willie Fox says that he was the last member of the Fox family. He was buried in the family lot in Greenwood Cemetery, Park Rapids.

An article in the Park Rapids Enterprise February 11, 1915 reprinted from the Seattle Evening Telegram shows that the Zimbricks were living in Seattle at that time.

The headlines read "William Zimbrick can hunt, write and do many other stunts with ease.

His left arm was taken off above the elbow and his right arm at the wrist.

After being treasurer of Hubbard County for six years, he along with his wife moved to Seattle, Washington.

When small game hunting season opened he was one of the first to apply for a license. The clerk asked if he was getting a license

for a friend. Will said, "I want a license for myself". Zimbrick used an ordinary double barrel shotgun. The butt was bored so he could screw a flat extension which he gripped under his right arm and rested the barrel on the steel hook. He pulled the trigger with a chain held in his teeth. He came back from the hunt with 4 pheasants, 1 rabbit, 1 Quail and 1 partridge. He also had a special strap that allowed him to use a crosscut saw. He rode a bicycle by grasping a handle bar with the steel hook. He could remove the hook and screw on a fork that he used for cooking. He was able to dress himself, but always wore gaiters to avoid lacing his shoes.

In Seattle he worked as a salesman for a nursery company. He wrote and signed his name with a pencil held with his teeth.

He lived in Seattle, but also had a homestead in Zinn County, Washington.
